13 July 2019	Seminar 16 – Getting Ready for 1 August
	The Registrar has mandated that, from 1 August, any transaction that can be lodged electronically will be required to be lodged electronically. New functionality has been developed in PEXA to allow electronic lodgement of instrument types that previously could not be lodged electronically. These documents are known as residual documents.
	Land Use Victoria, State Revenue Office and PEXA have been working to provide the ability for residual documents to be lodged electronically.
	SRO is developing a built in ability to complete complex transactions end-to-end.
	At this seminar, held on 13 July 2019, Richard Jefferson and Paul Major from LUV, Paul McKee of SRO and Jonathan Teh of PEXA discussed these changes and participated in a panel discussion to help you deal with the changes.
